*Sheila C. Bair*, Senior Advisor to The Pew Charitable Trusts; former Chairman of the Federal Deposit Insurance Corporation; Dean's Professor of Financial Regulatory Policy at the University of Massachusetts Amherst; Senior Vice President for Government Relations at the New York Stock Exchange.

*Alan S. Blinder*, Gordon S. Rentschler Professor of Economics and Public Affairs at Princeton University; Co-director and Founder of Princeton's Center for Economic Policy Studies; Vice Chairman of the Promontory Interfinancial Network; columnist for *The Wall Street Journal*; former member of the President's Council of Economic Advisors and Vice Chairman of the Board of Governors of the Federal Reserve System.

John C. Bogle, Founder and former CEO of The Vanguard Group and President of Vanguard's Bogle Financial Markets Research Center; author of ten books, including in 1999 Common Sense on Mutual Funds: New Imperatives for the Intelligent Investor, which became a bestseller and is considered a classic. He serves on the Board of Advisors of The Institute for the Fiduciary Standard.

**Peter G. Fitzgerald**, JD, President of Chain Bridge Bank in McLean, Virginia; former U.S. Senator from Illinois and State Senator in the Illinois General Assembly; Trustee of the National Constitution Center in Philadelphia and Co-chairman of the Capital Campaign for the American Philological Association.

**Burton G. Malkiel**, Professor of Economics at Princeton University; former member of the Council of Economic Advisors; President of the American Finance Association; Dean of Yale School of Management and author of the investing bestseller, *A Random Walk Down Wall Street*.

**David F. Swensen**, Chief Investment Officer at Yale University; inventor of the "Yale Model," an application of Modern Portfolio Theory; former Senior Vice President of Lehman Brothers and Associate in corporate finance for Salomon Brothers; serves as trustee of TIAA and non-executive director of Schroders PLC.

*Paul A. Volcker*, Director and Counsel to a number of corporation and nonprofit organizations; former Chairman of the Federal Reserve and the Economic Recovery Advisory Board; former President of the Federal Reserve Bank of New York; former Undersecretary of the Treasury for International Monetary Affairs; former Chairman of Wolfensohn & Co., former Chairman of the Independent Committee of Eminent Persons charged with investigating and settling dormant accounts of Jewish victims of the Holocaust.
