

Sample of CFPs' Who Report to be Fee-Only Advisors

March 8th, 2018

In light of CFP Board making revisions to its proposed standards (tentatively set to be finalized and released in Q2 of 2018), the Institute conducted research to determine the percentage of CFPs among the 79,935 nationwide 1 who report they are fee-only.

The Institute surveys the top 10 U.S. metro areas by population according to data estimates from the U.S. Census Bureau as of July 1st, 2016. For data robustness, data from the top 10 U.S. metro areas with populations under 300,000 are also surveyed. Five more rural states are also surveyed

In the top 10 U.S. metro areas, there are 10,244 CFPs, of which 1,503 are Fee-Only (or 14.67%).

In the top 10 U.S. metro areas with under 300,000 population there are 388 CFPs, of which 56 are Fee-Only (or 14.43%).

In the 5 rural states² sampled, there are 1,143 CFPs, of which 164 are Fee-Only (or 14.35%).

These data represent a significant departure from some prior surveys that have estimated the proportion of Fee-Only CFPs. A 1999 CFP study found that 25% of advisors were Fee-Only, and a 2009 FPA study of CFP members found 31% to be Fee-Only.³

Population density is taken from a list of the top 382 Metro Statistical Areas (MSAs) of the U.S. ranked by population as of July 1, 2016 as estimated by the U.S. Census Bureau. CFPs from each metro area are aggregated within a 25-mile radius of the metro areas' downtown districts. The classification "All Other CFPs" is made up of CFPs who are compensated by "Fee + Commission," "Commission Only," or those who do not list a compensation method.
